REACH STATEMENT of ALPHA 3 MANUFACTURING GROUP (As at January 2021)

The Alpha 3 Manufacturing Group comprising DEM Manufacturing, CTL Manufacturing, CCS Electronics and Tekdata Interconnections Ltd is fully aware of the requirements given by REACH Regulation (EC) No 1907/2006 and has identified its roles and obligations to the best of its knowledge.

- 1. Alpha 3 Manufacturing Group is a **Downstream User**, a **Producer of Articles**, an **Importer of Articles** and a **Supplier of Articles**
- 2. Alpha 3 Manufacturing Group confirms that we understand our obligations within REACH in all of our roles as defined above.
- 3. Alpha 3 Manufacturing Group is located inside of the EU.
- a) For our suppliers, located within the EU, we are acting as a Downstream User for substances and preparations and as a Supplier of Articles for articles. Therefore they have to fulfil the obligations given by REACH.
- b) For our suppliers, which are located outside of the EU we are acting as Importer of Articles for articles with all obligations relevant to us.
- 4. Alpha 3 Manufacturing Group **does not intend to register** any substances as we **do not sell substances, preparations nor articles containing any substances that are intended to be released at any time.** Therefore registration is not required.
- 5. Alpha 3 Manufacturing Group is in contact with all of our suppliers (located inside and outside of the EU) in order to get proper information and to ensure the availability of articles in the future.
- 6. Alpha 3 Manufacturing Group will monitor all further obligations with regards to Annex XIV (the "Authorisation list"), Annex XVII ("Restriction of Substances") and the Candidate List of substances of very high concern for Authorisation.
- 7. This "Candidate List" was published on 28th of October 2008 and last time amended on 19th January 2021. Complete knowledge of the presence of these substances (211) included in the actual "Candidate list" in the articles we supply is not yet present as our suppliers have not finished their assessment. We will inform you immediately once we are informed by our suppliers of any findings of SVHCs from the actual Candidate List in products you purchase from us.
